





The UvA-NEMO Smile Database License Agreement v2.0

The University of Amsterdam is the owner of the database, and retains all rights and responsibilities for its non-commercial distribution to the scientific community. This research was part of Science Live, the innovative research program of science center NEMO that enables scientists to carry out real, publishable, peer-reviewed research using NEMO visitors as volunteers. Volunteers (or their legal guardians, in the case of minors) signed permission forms granting researchers access to the data under the conditions indicated below.

The UvA-NEMO Smile Database is made freely available for research and education purposes on a case-by-case basis. All requests for the database must be submitted in writing by the researchers' institution, prior to the release of the database. To receive a copy of the database, the researcher must agree to the conditions below, and sign this document. The permission to download the database will be granted after the receipt of the signed document.

Conditions:

- **1. Redistribution:** We agree that the copy we receive is to be used for research and education purposes by our research group only. We will not redistribute any part of the database.
- **2. Protection of identity:** The identity of the subjects in the database is strictly protected. Names are not released. We agree not to disclose the names of the persons in the database and to connect the data with the names, if we get this information through another source.
- **3. Modification:** We agree not to modify the database in any form.
- 4. Commercial use: We will not use the original data or modified copies for any commercial purposes.
- **5. Publication:** We agree not to publish any images of the subjects (including publication in scientific papers, posters, websites, video or image demonstrations) except the ones marked as publishable. These are subjects numbered between 1 and 50, as well as subjects 400 and 401.
- **6. Warranty:** The database comes without any warranty. University of Amsterdam is not responsible for any damage caused by the use of the database.
